Food Safety Assessments:

Assessments in the form of written questions and case studies are done during the class. Students will also be required to complete a Demonstration of Skills Checklist for both levels. This assignment will require help from another person (3rd Party) to observe the student completing a number of tasks. The 3rd Party observer can be anyone at all, a friend, family member or colleague that has a qualification **OR** experience working with food preparation.

Assignments can be completed in a workplace or simulated workplace (home) if you are not yet working.

The observer will need to make comments on what the student explains/tells/demonstrates while completing the tasks. We require detailed comments; YES/NO/NA will not be accepted. The observer will also be required to provide details of their experience or qualifications.
